

SINGLETON SPACES 50:50 CLUB RULES

The Singleton Spaces 50:50 Club ("the Club") will operate as a Small Lottery as defined by the Gambling Act 2005.

The object of the Club is to raise funds for Singleton Spaces.

The subscription to the Club shall be £60 per year per membership payable in advance, either by monthly Standing Order or as a single annual payment.

Members may have and are encouraged to have multiple subscriptions.

The subscription year runs from September to August the following year. There is no provision to opt in/out on a month by month basis.

Members joining after the start of the subscription year will be charged a pro-rata amount for the rest of the year until August and entered in the next available draw following payment.

If a person who joins after the start of the subscription year wins the annual prize, then the value of the annual prize will be pro-rated down accordingly and the remaining money put into the revenue for the following year's funds (for example, if the winner of the annual prize has only paid 6 months subscriptions, then the annual prize value will be halved).

Anybody can become a member of the Club and you are encouraged to get family and friends to join.

The Club shall not be limited to a specific number of members.

A member is eligible for inclusion in the draw for any month so long as the subscription for that month has been paid.

Each member is allocated a permanent number in the monthly draw. This number shall remain the member's number provided that their subscription is up to date.

There shall be draw of 3 prizes per month (if the scheme has 200 members or fewer) or 4 prizes per month (if the scheme has more than 200 members), with an additional annual prize to be drawn in December of the following subscription year. The annual prize will be drawn at the Christmas Fair.

The draw for each month shall be made as close to the 12th of each month as arrangements reasonably allow.

The draws will be made by a person who is not a trustee in the presence of at least two trustees, using a random generator number application to select the winning numbers.

Monthly prizes will be awarded according to membership of the Club for that month as follows:

If the Club has 200 members or fewer:-

- 20% of the annual net payments will make up the annual prize.
- 15% of the annual net payments make up the monthly 1st prizes (12 prizes of 1.25% each).
- 9% of the annual net payments make up the monthly 2nd prizes (12 prizes of 0.75% each).
- 6% of the annual net payments make up the monthly 3rd prizes (12 prizes of 0.5% each).
- The remaining 50% of the annual net payments will be allocated to Singleton Spaces funds.

If the Club has more than 200 members:-

- 20% of the annual net payments will make up the annual prize.
- 12% of the annual net payments make up the monthly 1st prizes (12 prizes of 1% each).
- 7.2% of the annual net payments make up the monthly 2nd prizes (12 prizes of 0.6% each).
- 6% of the annual net payments make up the monthly 3rd prizes (12 prizes of 0.5% each).
- 4.8% of the annual net payments make up the monthly 4th prizes (12 prizes of 0.4% each).
- The remaining 50% of the annual net payments will be allocated to Singleton Spaces funds.

The allocation of numbers and draw results will be posted on the Singleton Spaces website, and winners will be contacted individually via email immediately after each of the prize draws.

The Club administrators will make all reasonable efforts to pay or post prizes to the winners within two weeks of the draw.

Payment of prize winnings will be made by bank transfer.

Unless otherwise advised, a member will be deemed to have left the Club if his/her subscription renewal remains unpaid for a period of one month.

If a winner cannot be contacted, the winnings will be placed into Singleton Spaces funds after six months.

The decision of the Singleton Spaces trust shall be final in all matters requiring adjudication. The Singleton Spaces trust shall also have the power to amend or revoke these rules at their absolute discretion with such reasonable notice to the Club members as is necessary.
